As you will recall, the Ely City Council took on the issue of the USDA Forest Service plan to shut down the Elderberry and Ice Plant Dam Removal Project at its regularly scheduled City Council meeting on February 22, 2017. During the meeting Councilmember Setterstrom requested that you not provide any findings in the matter until after the City could hold a public hearing with the citizens of the City of Ely. Because of how the City is required to hold public hearing you verbally agreed at that time to withhold any findings until this matter could be heard on or about March 23, 2017.

Further, please let this letter serve as the City's official request that you appear at the March 23, 2017 meeting to address any potential issues identified by members of the public or the City Council following the public hearing.
